The Ruidoso Valley Chamber of Commerce is pleased to invite you to apply as a Food Vendor for our 38th Annual Ruidoso Art Festival. This year's festival will be held **Friday, July 24th through Sunday, July 26th** at the Ruidoso Convention Center.

Enclosed is your Food Vendor application. Please note the application deadline of **May 15th, 2009**. We strive to offer a variety of food choices for our artists and visitors, so we ask that you be specific in indicating the food and drinks to be offered in your booth. Vendors will be selected based on menu, followed by date of receipt of the application. Any last minute menu changes will require Chamber approval. The Ruidoso Art Festival has a proven record of being a fun and profitable event for our Chamber of Commerce, and it is our goal for the Food Vendors to share in this success.

The cost per space for Food Vendors is \$175 for Commercial and \$125 for Non-Profit. Should you be accepted as a Food Vendor and decide to cancel prior to **June 15th**, you will receive a full refund less a \$25 handling fee. We regret that no refunds will be given after June 15th, 2009. Please remember that a Temporary Food Service Permit must be filed with the New Mexico Environment Department no later than one week prior to the Festival. There is a \$25.00 fee for this service if you do not have a permanent New Mexico Food Service Permit.
